The following describes the terms under which Hammer 'Em Outfitters will provide you with hunting services, describes information concerning the weather, terrain, facilities and equipment you will encounter, and provides you with information regarding the qualifications and experience of our staff. Before you begin your hunt with Hammer 'Em Outfitters, we require that you approve and agree to the terms and conditions stated in this letter by signing a copy of this letter in the space provided below.

Services and Accommodations:

Hammer 'Em Outfitters will provide you with the following services and accommodations during your stay with us:

- One pro guide per hunter for archery and one pro guide per two hunters for general season rifle hunts.
- Field dressing, delivery of game meat to the local processor of your choice and delivery of trophy heads to local taxidermist of your choice.
- Transportation in and around the hunting area for the 5 day hunt.
- Transportation to and from the Great Falls International Airport, Great Falls, MT.
- Parking area for your vehicle(s) if you will be driving Hammer 'Em Outfitters.
- Lodging and meals will be provided at Walker Camp at Lingshire, MT.

Hammer 'Em Outfitters will provide you only the services and equipment specifically described in this agreement. As an example of the services Hammer 'Em Outfitters will not provide, you will be responsible for the cost of taxidermy and all costs of packaging, processing and shipping of meat, capes and heads.

Minimum Equipment and Licensing Requirements

To assure you the most successful and comfortable hunt possible, Hammer 'Em Outfitters requires each hunter to provide certain personal equipment. You must provide at least the following:

- Archery Hunts - archery equipment in good working condition - bow, arrows and broad heads all intended for hunting purposes; *all hunters will be asked to shoot with their guide before the hunt begins*
- Rifle Hunts - rifle and scope of at least 270 caliber or greater in good operating condition and ammunition to down elk size wild game; *all hunters will be asked to shoot with their guide before the hunt begins*
- Appropriate clothing including (400 square inches of hunter orange in an outer garment worn above the waist; *(rifle hunters only)*)
- Personal Items (*see Gear List*)

In addition, you must obtain, at your expense and have in effect at all times, a valid Montana Big Game Hunting License, and all archery hunters are required to purchase an archery stamp. If you were born after January 1st, 1995, you must have a valid Hunter Education Certificate, in your possession at all times. If a hunter is unsuccessful in the current Non-Resident License Draw the hunter can either leave his/her deposit for dates booked in the following year or a full refund will be issued on May 1st of the current year. Draw results will be available the 3rd week in April via Montana Fish, Wildlife and Parks website, and Hammer 'Em Outfitters will be checking everyone's results at that time. Statistics are showing that everyone applying for a Non-Resident elk or deer tag will have better than a 95% chance of drawing a license.

A 50% deposit is required to reserve your hunt with the balance due July 1st; Deposits for all hunts are non-refundable but can be applied to other available hunts or replacement within the same season. Deposit refunds will be made if the conditions of our agreement with you are not met because of conditions beyond our control, such as weather so severe as to prevent unsafe hunting, or a hunter does not draw a license for the year booked.

Confirmation of your Hunt

In order to confirm the scheduling of your hunt and hold your reservation of the dates and hunt detailed in this letter, Hammer 'Em Outfitters will need to receive from you:

- A signed and dated copy of this Hunter/Guest Agreement and Reservation Form.
- A 50% deposit for your hunt, guests or film crew.

Hammer 'Em Outfitters will observe and follow all Montana Fish, Wildlife, and Parks Rules and Regulations that apply to your hunt and will strictly enforce them. If a violation occurs while hunting with us, Montana Fish, Wildlife and Parks authorities will be notified immediately.

One of our highest priorities is to minimize the damage to and harassment of the existing wild game on the property. This practice benefits all present and future hunters on the property. For this reason, all aspects of your hunt will be controlled by your pro guide at his sole discretion, with this end in mind. In order to minimize uncertain shots and the wounding of animals, **any wounded animal will be considered a dead animal for the purpose of filling your license for that species. There will be no exceptions. First Blood is the Hammer 'Em policy.**

The Annual Licensing deadline is 5 o'clock p.m. March 15th, we recommend applying for your license [online \(https://app.mt.gov/Als/Index\)](https://app.mt.gov/Als/Index) if you are unable to apply online please contact Hammer 'Em Outfitters and we will provide you with a paper application.

If you are hosting/providing payment for guests in addition to yourself, it is necessary as the host of your group, to provide the 50% deposit and Hunter/Guest Agreement and Reservation Form for each of your guests.

Hammer 'Em Outfitters has attempted to provide you with as much detail as possible concerning your hunt with us in order to avoid confusion and to make your hunt more pleasant. Please contact Hammer 'Em Outfitters before you arrive if you have any questions concerning any aspects of your hunt. We look forward to having you as our guest.
